On December 15, 2023, the Public Utilities Commission (Commission) issued Order No. 26,913, in which it required Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty (Liberty or the Company) to file a proposal for an ISO-New England market-based procurement tranche of 10 to 20 percent, through whatever combination of direct Day Ahead and Real-Time ISO-New England market acquisitions the Company finds advisable, for the Company's upcoming August 2024-January 2025 energy service period for its small customer group, to be assessed by the Commission in a future phase of this proceeding. Liberty submitted this filing on January 29, 2024.

On February 8, 2024 the Commission issued a Supplemental Order of Notice to assess the proposal and directed the Department of Energy to submit its position regarding Liberty's proposal by March 6, 2024.


