Request for Approval of Berlin Community Power Plan

ORDER OF NOTICE

On April 24, 2024, the City of Berlin (Berlin) filed its Community Power Electric Aggregation Plan (the Plan) with the Commission pursuant to RSA 53-E:7 for Commission review and approval. RSA 53-E:7, II provides that

The commission shall approve any plan submitted to it unless it finds that it does not meet the requirements of this chapter and other applicable rules and shall detail in writing addressed to the governing bodies of the municipalities or counties concerned, the specific respects in which the proposed plan substantially fails to meet the requirements of this chapter and applicable rules.

This filing raises, *inter alia*, issues related to whether the Plan meets the requirements of RSA chapter 53-E and applicable rules.

RSA 53-E:7, II also directs the Commission to accept public comments for 21 days after receiving any such request for approval of a community power electric aggregation plan, and states that the Commission's review of the Plan and comments shall not require a contested case. Accordingly, the Commission hereby provides notice that it will accept public comments on the Plan within the first 21 days from the date of submission, or until **May 15, 2024.** Comments shall be addressed to the Chairman of the Commission, by mail at:
