### Interconnection Agreement Between TDS Telecom and Level 3 Communications, LLC

# Order Establishing New Publication Deadline for Compliance with Order No. 26,926

# <u>O R D E R N O. 26,983</u>

#### March 22, 2024

On January 5, 2024, the Commission issued Order No. 26,926, an order *nisi* approving an amendment to an interconnection agreement between TDS Telecommunications, LLC (TDS Telecom) and Level 3 Communications, LLC. The order required TDS Telecom to post a copy of the order on its website by January 9, 2024. The order stated that it would take effect on February 2, 2024, unless an interested party filed an objection, TDS Telecom failed to comply with the publication deadline, or the Commission ruled otherwise in a supplemental order.

On February 15, 2024, TDS Telecom filed a letter with the Commission representing that it had not been aware of the order because the email notification had been inadvertently diverted to its counsel's junk email folder. As a result, TDS Telecom did not publish a copy of the order by the January 9 deadline and therefore the order did not go into effect on February 2, 2024. TDS Telecom now requests that the Commission establish a new publication deadline.

Based upon the foregoing, it is hereby

**ORDERED**, that TDS Telecom shall post copies of both Order No. 26,926 and this order on its website <u>no later than March 29, 2024</u>, to be documented by affidavit filed with the Commission by April 5, 2024;

**FURTHER ORDERED**, that all persons interested in responding to Order No. 26,926 be notified that they may submit their comments or file a written request for a hearing which states the reason and basis for a hearing no later than <u>April 19, 2024</u>, for the Commission's consideration; and it is

**FURTHER ORDERED**, that any party interested in responding to such comments or request for hearing shall do so <u>no later than April 26, 2024</u>; and it is

**FURTHER ORDERED**, that this order shall be effective May 1, 2024, unless TDS Telecom fails to satisfy the publication obligation as set forth above or the Commission provides otherwise in a supplemental order issued prior to the effective date.
