# **SUPPLEMENTAL ORDER OF NOTICE**

On December 16, 2020, the Commission issued Order No. 26,435 suspending Pittsfield Aqueduct Company, Inc.'s (PAC) proposed tariff for temporary and permanent rate increases pending further investigation. This supplemental notice updates the previous notice due to the expiration of the declared State of Emergency on June 11, 2021.

With the expiration of the State of Emergency, the Commission must now comply with all requirements of RSA chapter 91-A, including the requirement that a quorum of a public body must be physically present at the location specified as the location of the public meeting in the meeting notice. The Commission is aware that not all parties, including regulated utilities, have returned to full in-person work environments. Therefore, for the foreseeable future, the Commission intends to provide a hybrid approach to hearings to accommodate those who are remote and those who are physically present. A quorum of Commissioners will be physically present within a hearing room for all Commission hearings beginning June 14, 2021. In order to facilitate the hybrid approach, the Commissioners will also continue to participate on the webenabled platform. Parties and the public may continue to participate in hearings remotely using the Commission's web-enabled platform.
