# Review of GLA Goals

## 1.3 Establish a Self-Sustaining Fund for EE Projects in State Government

- Demand Response
- Energy Conservation Bonds
- Set aside portion of energy budget(s)
- Current funding from Capital Budget Appropriations, ARRA, voluntary agency investments

# Review of GLA Goals

## 2.1 Apply High Performance Building Standards to New Construction and Renovation

- Update Executive Order 2005-4 on energy efficiency in state operations
- SB409 calls for high performance building standards for state-funded buildings (with 10 year payback, >25k sq ft, other exemptions)

# Review of GLA Goals

## **3.1 Encourage RE and EE for Existing State-owned Buildings and Facilities**

- SB73 will call for annual energy conservation plans from all state agencies
- State Energy Manager provides technical assistance to agencies on energy efficiency and renewables

# Review of GLA Goals

## 3.1 Encourage RE and EE for Existing State-owned Buildings and Facilities

- Kilowatt Countdown
- Walker Building pilot w/motion sensor power strips
- OEP likely to fund study on RE potential at state facilities and lands
- \$3 million in capital funds ARRA funds
