	Questions	Answers
1.	We understand the number of hearings, hours, etc. Of those, historically, how many have required remote attendance?	If this question is asking how many remote court reporters the Commission has utilized in the past, the answer is none. If this question is asking how many of our in-person hearings have remote participation we estimate that approximately 1/4 of hearings have remote attendance, and there is a mix of remote and in person attendees. Typically, there are 1-4 people attending remotely if there is remote attendance.
2.	To ensure we create a page rate not exceeding \$369,000, could you please let us know how many pages of transcript from remote attendance were produced?	The Commission has not used remote stenographers in the past. All of our transcripts, unless confidential, are placed in our dockets in the virtual file room. 6.	Transcript delivery seems to be hard copy (original & 1) and electronic delivery. Is this an either or both delivery?	Either, as directed by the PUC.
7.	Are transcripts delivered to PUC only or does the Vendor also deliver transcripts to participants?	PUC only. The PUC posts in the docket for all parties to see in the virtual file room on the Commissions website. (https://www.puc.nh.gov/Regulatory/VirtualFileRoom.html)
8.	Is there a current Vendor? If so, has this Vendor provided services for more than one contract period?	There is not a current vendor for Remote Court Reporting & Transcription Services.
