# NOTICE OF PRE-HEARING CONFERENCE

## Petition for Valuation of the Pennichuck Utilities by the City of Nashua

**July 28, 2004

On March 25, 2004, the City of Nashua filed with the New Hampshire Public Utilities Commission a Petition for Valuation pursuant to RSA 38:9 seeking the Commission's determination of the fair market value of the plant and property of Pennichuck Corporation's three regulated utilities: Pennichuck Water Works, Inc., Pennichuck East Utilities, Inc., and Pittsfield Aqueduct Company, Inc (collectively, the "Pennichuck Utilities").

Several pleadings have been filed in this docket including a motion to dismiss filed by the Pennichuck Utilities, a motion to disqualify the Pennichuck Utilities' Counsel filed by the City of Nashua and a motion to consider and maintain effectiveness of an existing contract filed by the Town of Milford.

The Commission is holding a Pre-Hearing Conference for the limited purpose of addressing motions for intervention, the current procedural status of other court proceedings and to hear oral argument on the above referenced pleadings.

The Pre-Hearing Conference will be held at the Commission's offices in Concord on July 28, 2004 at 10:00 a.m. and is open to the public. Parties wishing to obtain intervenor status should send an original and eight copies of a written request to the Commission by July 23, 2004, with copies to the Office of the Consumer Advocate.
