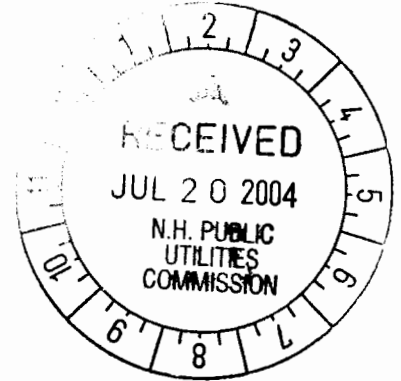

TOWN OF PITTSFIELD'S PETITION TO INTERVENE

NOW COMES the Town of Pittsfield ("Pittsfield"), by and through its attorneys Mitchell & Bates, P.A., and petitions the New Hampshire Public Utilities Commission ("the Commission") to allow it to intervene in the above captioned matter. In support of this Petition, Pittsfield states as follows:

1. On March 25, 2004, the City of Nashua, New Hampshire filed with the Commission a Petition for Valuation pursuant to RSA 38:9. Nashua seeks the Commission's determination of a fair marked value of the plant and property of Pennichuck Corporation's three regulated utilities: Pennichuck Water Works, Inc., Pennichuck East Utilities, Inc., and Pittsfield Aqueduct Company, Inc.
2. Pittsfield Aqueduct Company, Inc. is a New Hampshire Corporation formed in 1997 and granted operating authority by this Commission to provide water service to the residents of Pittsfield.
3. Pursuant to RSA 541-A:32 and Puc 203.02, Pittsfield petitions the Commission to permit it to intervene in this matter.
4. The Pittsfield Aqueduct Company, Inc., supplies many of the homes in Pittsfield with water. Pittsfield has joined the Regional District in attempting to acquire Pennichuck, and eventually, if the voters of Pittsfield vote to raise the funds, Pittsfield hopes to buy the Pittsfield Aqueduct Company, Inc.'s property and system to continue supplying water to its residents. In so doing, Pittsfield would maintain water service and costs, thereby preserving the public health, land values, and potential for economic

development in the town.

5. As such, the rights, duties, privileges, immunities and other substantial interests of the residents of the Town of Pittsfield may be affected by the present proceeding.

6. The interests of justice and the orderly and prompt conduct of the proceedings would not be impaired by allowing the intervention.

WHEREFORE, the Town of Pittsfield respectfully requests that this Commission:

- A. Permit it to intervene in the above captioned matter; and
- B. Grant such other and further relief as the Court deems just and necessary.
