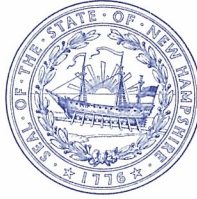

Procedural Schedule

To the Parties:

On November 5, 2008, Staff filed a report of a technical session held in the above-captioned docket. In its report, Staff outlined the participants' agreement on a proposed procedural schedule and a uniform method for calculating amounts at issue in Phase II of the proceeding. The proposed schedule includes briefing on the issues of applicable reparations period(s) and interest rate(s), submission of refund/credit calculations, and break-out sessions, as necessary, concerning the amounts at issue.

The Commission reviewed and approved the schedule and calculation method outlined by Staff. Accordingly, the procedural schedule was established as follows:
