

Dear Ms. Howland:

Pursuant to the case schedule agreed upon by the parties and Staff at the technical session in this proceeding on November 5, 2008, enclosed for filing is a CD containing Excel spreadsheet files of Verizon New England Inc.'s Exhibit of Disputed CCL Charges that have been paid to Verizon by the intervenors in this proceeding. A hard copy is also enclosed.

As stated in Verizon New England's Brief Regarding Calculation of Reparations, the time periods used in the Calculations were selected by Staff at the technical session in order to provide the Commission with data for all reparations periods claimed by the CLECs. They do not represent Verizon's position on the time periods that apply to the CLECs' claims.<sup>1</sup>

Verizon requests that the enclosed information be treated as confidential, proprietary information pursuant to RSA 378:43. The Calculations of Disputed Charges, which have been marked "confidential" on both the CD and hard copy, pertain to the provision of competitive services; set forth trade secrets or other confidential information

Any disputed CCL charges a carrier paid after Verizon transferred its accounts to FairPoint on March 31, 2008, would have been remitted to FairPoint and are thus not subject to refund by Verizon.

falling within the scope of RSA 378:43, II(b); and are not general public knowledge or published elsewhere, Verizon having taken measures to prevent dissemination of the information in the ordinary course of business. (The individual carrier calculations for minutes of use and revenues are customer proprietary and pertain to the provision of competitive services among the respective competitors. Disclosure would set forth confidential financial, commercial and market information of customer and product-specific data on usage and revenues not otherwise publicly available nor reflected in tariffs of general application.) Verizon is providing copies of proprietary information specific to a particular carrier to the Commission and to that carrier only.
