**ONE COMMUNICATIONS' ESTIMATE OF IMPROPERLY BILLED
VERIZON NEW HAMPSHIRE ACCESS CHARGES**

One Communications provides the following estimate of the general order of magnitude of the disputed charges billed by Verizon New Hampshire, in accordance with the procedural order dated November 29, 2006 (Order No. 24,705).

One Communications' estimate of the amount of improper access charges is approximately \$956,000, through the most recent bills received by each of the One Communications operating companies in New Hampshire (Choice One of New Hampshire Inc.; Conversent Communications of New Hampshire, LLC; CTC Communications Corp.; and Lightship Telecom, LLC).¹ One Communications continues to re

One Communications calculated this figure by extracting data from the bill data tapes (BDTs) that Verizon New Hampshire provided to One Communications' operating subsidiaries. For each monthly billing cycle for each operating company, One Communications screened out interstate calls and intrastate, non-cellular calls. One Communications thus obtained the aggregate minutes of use represented by the intrastate cellular calls. Multiplying the intrastate cellular minutes of use times the per-minute carrier common line access charge that Verizon

assessed to each minute of use (\$0.026494) yielded the aggregate improper access charge per month.

One Communications also is providing to the Commission a set of worksheets showing its calculations. One Communications considers the information contained therein to be confidential and proprietary and commercially and competitively sensitive, and therefore is providing the spreadsheets to the Commission only, pursuant to RSA 378:43.²

One Communications notes the statement in Verizon New Hampshire's December 15, 2006 information request no. 2 concerning "'local' calls regarding which the parties have agreed to adjust and apply TTS rates." Verizon New Hampshire has not adjusted any of the One Communications operating subsidiaries bills in the manner described. Accordingly, no such adjustment was taken into account in calculating the estimate above.

One Communications further notes that this methodology relies on information provided by Verizon New Hampshire in its BDTs. Inaccuracies in Verizon's BDT data will adversely affect the accuracy of One Communications' estimate of the improper access charges.
