

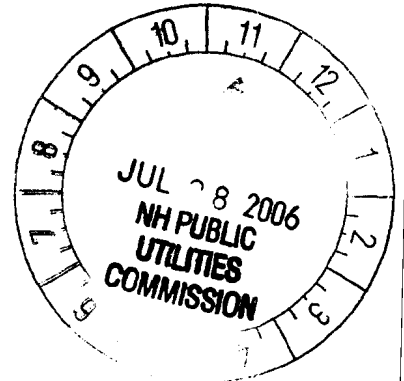



PETITION TO INTERVENE OF OTEL TELEKOM, INC.

Pursuant to Commission Rule 203.02, and RSA 541-A:32, Otel Telekom, Inc. hereby petitions the Commission to intervene in Docket No. DT 06-067.

I. Statement of Interest.

Otel Telekom is a facilities-based competitive local exchange carrier (CLEC) currently operating in New Hampshire pursuant to Commission Order No. 23,942 issued on March 29, 2002 in Docket No. DT 02-016.

The docket in question involves a request for Commission investigation into certain terms of New Hampshire Tariff #84 including but not limited into how Verizon interprets its own Tariff in relation to CLEC wholesale customers and whether or not any prospective Tariff modifications are appropriate (June 23rd Order of Notice p.3 item (5)).

Otel Telekom purchases substantial amounts of Verizon wholesale services via the tariff in question and may be affected by any Commission interpretation, evaluation, ruling, or change to this Tariff.

Accordingly, substantial interests of Otel Telekom may be affected by this proceeding. See RSA 541-A:32(I)(b) (2003).
