Dear Mr. Mobilia:

I am contacting you for an update on resolving the condition that the lots within the Bachelor Mountain subdivision are required to be served by a community water system. As you know, the lots cannot, without an amendment to the original subdivision approval, support private potable wells. This condition is an impediment to dissolution of the water system; which you have requested in this docket.

Staff met with NH DES and Mr. Neil Helberg, your consultant, in July and DES explained what documentation and process was needed to overcome, if possible, the community water condition. We understand your consultant and DES are exchanging information but we would like to know your time frame for having the subdivision application materials in to DES. This docket has been open for two years and progress has been slow on your burden to show termination of the franchise is in the public good. Since most customers are taking water from illegal sources, public health reasons necessitate the Commission reevaluating continuing this docket or opening a separate enforcement docket.

Secondly, Staff would like to address a statement your consultant made in an email to DES and Staff to the effect that absent any movement toward resolution of the subdivision issue, you would be discontinuing the power to the pump house in the near future. If this is an accurate statement, pursuant to RSA 374:22, you cannot discontinue the water system until you obtain approval from the Commission. Again, we would appreciate knowing your intentions. Please feel free to contact me at (603) 271-2431 if you have any questions or wish to discuss this further.
