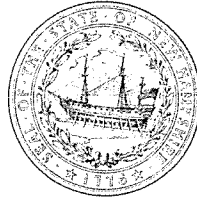

On March 29, 2012, you filed on behalf of Granite State Electric Company d/b/a National Grid's (National Grid), a request for a thirty-day extension of time to file its 2011 annual storm fund report in the above-referenced proceeding. The report was due April 1, 2012. In your request you state that the extension would allow National Grid to verify storm costs charged to the fund in 2011. You also indicate that you have conferred with Staff and Staff has agreed to the 30-day extension.

The Commission has determined that the extension will not unduly delay the proceeding or adversely affect the rights of any party. Accordingly, National Grid's 2011 annual storm fund report is due May 1, 2012.
