On January 23, 2008, Crossroads Wireless Holding, LLC (Crossroads) and Verizon New Hampshire (Verizon) jointly filed a petition for approval of an Interconnection Agreement (Agreement) between Verizon and Crossroads pursuant to Section 252 of the Telecommunications Act of 1996, 47 U.S.C. §252(e).


On April 17, 2008, FairPoint Communications (FairPoint) filed a letter informing the Commission of FairPoint's assumption of existing Verizon Agreements following the March 31, 2008 transfer of landline assets and operations from Verizon to FairPoint. According to the FairPoint filing, the Verizon – Crossroads Agreement is still pending assignment. Upon receipt of written consent from Crossroads, the Agreement, as amended, will become a FairPoint – Crossroads Agreement.

The Commission elects to take no action on this petition. Accordingly, pursuant to 47 USC §252(e) (4), the Agreement will take effect by operation of law 90 days after its filing. Notwithstanding the foregoing, any clause in the Agreement found to be in violation of any Commission order is null and void.
