Please find attached the following on behalf of Consumer Energy Solutions, Inc., (“CES” or the “Company”) for submittal to the State of New Hampshire Public Utilities Commission (“NHPUC”):

- Registration Application for Electricity Aggregator
- Registration Application for Gas Aggregator
- Compact Disc with the above-referenced applications
- Check for \$500 (\$250 per application).

The Company received approval from the NHPUC on June 16, 2006, to provide electric aggregation service in New Hampshire (see DM 06-080) and the attached Registration Application for Electricity Aggregator is intended as a request for renewal of that approval.


Similarly, the Company received approval from the NHPUC on June 28, 2006, to provide gas aggregation service in New Hampshire (see DM 06-081) and the attached Registration Application for Gas Aggregator is intended as a request for renewal of that approval. The Company recently became aware that, pursuant to the N.H. Code Admin. Rules Puc 3003.02(e), it should have filed its request for renewal of its Gas Aggregator approval at least 60 days prior to the expiration of its registration (i.e., April 27, 2008). The Company had intended to file its renewal requests simultaneously, prior to the respective expirations of its Electric and Gas Aggregator authorizations, and inadvertently overlooked the “60 day prior” requirement

applicable to its Gas Aggregator authorization. The Company regrets missing the deadline and respectfully requests that the NHPUC consider this oversight an immaterial and unintentional violation of N.H. Code Admin. Rules Puc 3003.02(e).
