**PUBLIC SERVICE COMPANY OF NEW HAMPSHIRE'S MOTION FOR  
SUMMARY DISPOSITION UNDER RULES 10(1) and 25 (2)**

**ERRATA SHEET**

On August 12, 2009, Public Service Company of New Hampshire ("PSNH"), appellee in the above-captioned matter, filed a Motion for Summary Disposition and a Memorandum of Law under Supreme Court Rule 10 and Rule 25. Concerning the resale of Renewable Energy Certificates ("RECs") produced by Lempster Wind, LLC, PSNH twice stated that no such sale has taken place:

Freedom raises the hypothetical issue of selling Lempster Wind RECs outside of New Hampshire; however, no such sale has taken place. Motion at p. 3.

For example, PSNH has not sold RECs produced by Lempster Wind outside of the New Hampshire market or are any such sales proposed by PSNH to take place. Freedom requests this court to advise the Commission that such potential sales should not happen in the future. Memorandum Footnote 2,

These statements need to be corrected. PSNH made a sale of RECs produced by Lempster Wind, LLC in May of 2009 to an entity outside of New Hampshire. This sale was made after the Commission's decision in the proceeding below. Order No. 24,965 was effective May 1, 2009. Appellant's

Notice of Appeal, p. 32. PSNH could rely on that order as valid and in effect.
