Motion to Substitute Witnesses

NOW COME Constellation Energy Commodities Group, Inc. and Constellation NewEnergy, Inc. (collectively "Constellation") by and through their attorneys, McLane, Graf, Raulerson & Middleton, Professional Association, and move the Commission for leave to substitute Bruce McLeish and Thomas E. Bessette as the sponsoring witnesses for the testimony previously sponsored by Daniel W. Allegretti. In support of this motion, Constellation states as follows:

1. Daniel W. Allegretti, in his capacity as Vice President and Director of Wholesale Energy Policy for Constellation Energy Resources, LLC, prepared direct testimony that was filed in this proceeding on October 1, 2008.
2. Mr. Allegretti has recently left the employ of Constellation Energy Resources, LLC and is no longer affiliated with Constellation. Constellation desires to substitute two individuals, Bruce McLeish and Thomas E. Bessette, in Mr. Allegretti's place. Mr. McLeish and Mr. Bessette would adopt the substantive portion of Mr. Allegretti's testimony in its entirety. The only change in the testimony previously filed would relate to the identity of the witnesses and their educational and professional background.
3. Mr. Bessette is Vice President for Energy Policy for the New England market for Constellation NewEnergy Inc. Mr. McLeish is Senior Vice President of

Products and Pricing for Constellation NewEnergy, Inc. Together, they are familiar with the policy issues, facts and positions set forth in the testimony previously sponsored by Mr. Allegretti.

4. No party would be prejudiced by allowing Mr. McLeish and Mr. Bessette to adopt Mr. Allegretti's testimony because the parties have had a full opportunity to conduct discovery regarding the substance of the testimony. If the Commission staff or any party wishes to conduct discovery on the educational and professional qualifications of Mr. Bessette and Mr. McLeish, Constellation is prepared to agree to a reasonable schedule and process for doing so. Contemporaneously with this motion, Constellation is providing to the Commission staff and the parties, information concerning Mr. Bessette's and Mr. McLeish's educational and professional background.

WHEREFORE, Constellation respectfully requests that the Commission allow Bruce McLeish and Thomas Bessette to adopt as their testimony the prefiled direct testimony of Daniel W. Allegretti dated October 1, 2008.


