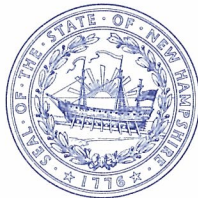

On January 14, 2009, you filed a request on behalf of the four New Hampshire electric utilities to extend the time from March 2, 2009 to March 20, 2009 to file the detailed reports describing their ability to expand the CORE programs. You note in your request that the electric utilities anticipate submitting a response on March 20<sup>th</sup> to the Commission's forthcoming Request for Proposals for programs funded from the Greenhouse Gas Emissions Reduction Fund and granting an extension of time will allow the utilities to "prepare a single filing that is responsive to both the Commission's information request and the RFP."

Please be advised that the Commission has granted your request. Accordingly, the electric utilities have until March 20<sup>th</sup> to respond to the Commission's January 14, 2009 request for information.
