10. The Granting of this petition will not impair the prompt and orderly conduct of the proceeding, will not result in delay, and will not prejudice the interest of any party.


11. The interests of justice will be promoted by allowing the intervention of the Home Builders & Remodelers Association of New Hampshire in this proceeding.
