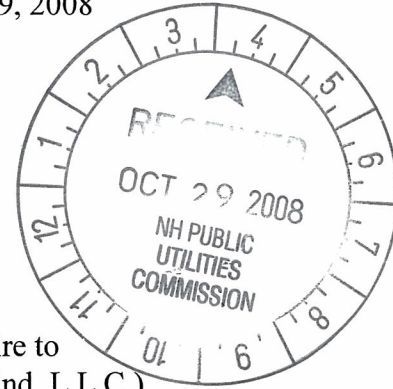

Enclosed please find an original and six copies of Public Service Company of New Hampshire's Agreed To Petition For Permission To Serve A Single Customer Within New Hampshire Electric Cooperative's Franchise Area In Lempster ("Petition"). As explained more fully in the Petition, the needs of the Lempster Wind turbines during start up require power at a voltage level that Public Service Company of New Hampshire ("PSNH") can serve. The New Hampshire Electric Cooperative, Inc. will serve the rest of the needs of this customer. Where PSNH seeks permission to serve only a portion of the load of a single customer, PSNH suggests that a franchise border change is not required.
