Dear Ms. Stewart:

On December 23, 2008, Soltage MGTCO 1, LLC (Soltage) submitted an application requesting certification of the Pilgrim Furniture City facility as eligible to produce Class II renewable energy certificates (RECs) pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law. Staff has reviewed the application and recommended approval noting that the Soltage application was complete on December 23, 2008.

Class II eligibility requires that a facility began operation after January 1, 2006 and that it produces electricity from solar technologies. The application indicates that Pilgrim Furniture City has installed solar photovoltaic equipment with a gross nameplate capacity of 0.325 megawatts located at 1755 Boston Post Road, Milford, Connecticut and that the facility began commercial operation on September 24, 2008. The facility's NEPOOL GIS facility code is 32699 and its ISO-NE asset identification number is NON 32699.

The Commission has reviewed the Soltage application and determined that it has provided all the necessary information to demonstrate that the Pilgrim Furniture City facility is eligible for certification as a Class II facility. Therefore, the Commission hereby certifies that the Pilgrim Furniture City facility is a Class II renewable energy source effective December 23, 2008 and is eligible to be issued New Hampshire Class II renewable energy certificates.

Attached please find a copy of the notice of this certification provided to the GIS administrator. The New Hampshire Renewable Portfolio Standard certification code for the Pilgrim Furniture City solar photovoltaic facility is NH-II-09-005.

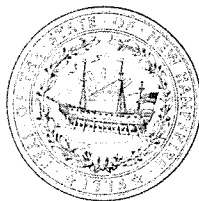

Please be advised that, pursuant to NH RSA 362-F, the New Hampshire Public Utilities Commission has certified the Pilgrim Furniture City facility as a Class II renewable energy source effective December 23, 2008. Accordingly, the Pilgrim Furniture City facility is eligible to be issued New Hampshire RPS Class II renewable energy certificates.

The Pilgrim Furniture City has installed solar photovoltaic equipment with a gross nameplate capacity of 0.325 megawatts located at 1755 Boston Post Road, Milford, Connecticut. The facility began commercial operation on September 24, 2008. The facility's NEPOOL GIS facility code is 32699 and its ISO-NE asset identification number is NON 32699. The New Hampshire RPS certification code is NH-II-09-005.
