
Participants agreed to the following proposed schedule:

Reponses to data requests due	August 21, 2009
Technical session	September 11, 2009 at 9:30 a.m.
Stipulation of facts due, if any	September 18, 2009
Simultaneous written testimony due	October 9, 2009
Data Requests on testimony due	October 23, 2009
Responses to data requests due	November 6, 2009
Simultaneous written reply testimony due	December 2, 2009
Technical session in lieu of discovery	December 9, 2009 at 9:30 a.m.
Hearing (estimated 2-days)	December 15 and 16, 2009
Briefs due (and requests for findings of fact and rulings of law, if any, due)	January 15, 2010
Reply briefs due	January 29, 2010

Staff agreed to receive and review data requests filed July 24, 2009, and then submit the data requests Staff has selected to each party or intervenor designated to receive them. The participants all agreed that their filings shall be simultaneously due, and that all responses to data requests will be sent to all parties and intervenors (except that all confidentiality rights are reserved).
