

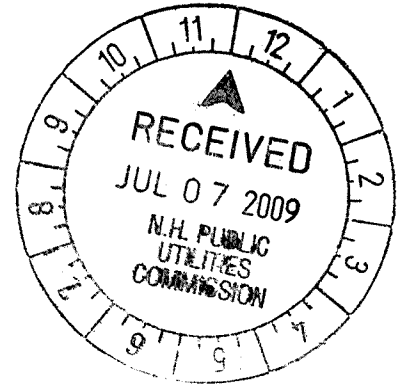

Re: Request for a Transitional and Long-Term Database Method for Local Number Portability

Dear Darren:

In response to your June 22, 2009 reply to IDT America, Corp.'s ("IDT") request for long-term number portability ("LNP"), please note that IDT's request was sent via email on June 10, 2009 at 5.10 p.m. A hard copy of the email is attached. Therefore, IDT finds it more accurate to state that the request was received on June 10, 2009 or, in the spirit of compromise since the email was sent after 5 p.m., June 11, 2009. Union's scheduled implementation should reflect that date.

Additionally, IDT does not find it necessary to substantively respond to the contingencies set forth in your letter other than to state that we will not agree to any requests to delay implementation of long term LNP nor do we agree with Union's (apparent) position that the conditions set forth in its letter would result in the lawful delay or elimination of IDT's request.

Finally, because Union raised in its letter issues directly and/or indirectly presented in Docket No. 09-048, IDT has determined that it is important for the Commission to be aware of IDT's request. Accordingly, IDT is filing this letter as well as both companies' prior communications regarding IDT's request for LNP with the Commission. IDT does not seek any action from the Commission at this time, but should the Commission conclude that issues raised, including, but not limited to, the question of whether IDT's request for LNP was, in fact, the first request made to Union, require the Commission's participation, IDT does not oppose such participation.

Dear Mr. Billek:

On June 12, 2009, Union Telephone Company (Union) received IDT America, Corp.'s (IDT's) request for Local Number Portability (LNP) dated June 10, 2009. Union will provide the requested long term database method for number portability (LNP) no later than six months from June 12, 2009 unless the following occurs prior to that time:

- 1) The New Hampshire Public Utilities Commission (NHPUC) or higher authority determines that Union is not required to provide local number portability until Union's rural exemption is lifted, or;
- 2) The New Hampshire Supreme Court finds that Metrocast or IDT's grant of authority issued by the NHPUC to operate as a competitive local exchange carrier within those areas served by Union was in error.

IDT America, Corp. ("IDT") hereby requests that, in accordance with 47 C.F.R. § 52.27(a) and all other applicable federal and/or state regulations, Union Telephone Company ("Union") make transitional number portability measures, as defined in 47 C.F.R. § 52.21(q), available to IDT on or before August 7, 2009 for the following Union end offices: Alton, NH; Gilmanon, NH; Barnstead, NH; Center Barnstead, NH; and New Durham, NH. For identification purposes; below is a table showing the present number block, rate center and switch CLLI-code for each end offices:

Also, IDT hereby requests that, in accordance with 47 C.F.R. § 52.23(c) and all applicable federal and/or state regulations, Union implement a long term database method for number portability for the above listed Union End Offices. In accordance with 47 C.F.R. § 52.23(c), the requested number portability must be available by no later than six months from the date of the receipt of this request.

Please respond within ten (10) business days of receipt of this request with a date for which transitional and permanent LNP shall be available in the requested End Offices. Should Union take the position that it is not required to comply with this request and/or that it is uncertain as to the nature of the request, IDT respectfully requests that Union contact IDT immediately to discuss this matter further.
