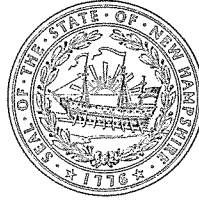

Pursuant to RSA 362-F

Dear Ms. Glenn:

On March 19, 2009, WM Renewable Energy, L.L.C. (WMRE) submitted an application requesting certification of the Crossroads landfill methane gas facility (Crossroads facility) as eligible to produce Class I renewable energy certificates (RECs) pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law. Staff has reviewed the application and recommended approval noting that the WMRE application was complete on May 11, 2009.

Class I eligibility requires a facility to have begun the production of electricity after January 1, 2006 and to use certain sources to produce electricity, one of which is methane gas. The application indicates that the Crossroads facility is powered by landfill methane gas, has a gross nameplate capacity of 3.2 megawatts and began commercial operation on March 6, 2009. The facility is located at 357 Mercer Road Norridgewock, Maine. The facility's NEPOOL generation information system facility code is MSS15998.

The Commission has reviewed the WMRE application and determined that it has provided all the necessary information to demonstrate that the Crossroads facility is eligible for certification as a Class I facility. Therefore, the Commission hereby certifies that the Crossroads facility is a Class I renewable energy source effective May 11, 2009 and is eligible to be issued New Hampshire Class I renewable energy certificates.

Attached please find a copy of the notice of this certification provided to the GIS administrator. The New Hampshire Renewable Portfolio Standard certification code for the Crossroads landfill methane gas facility is NH-I-09-025.

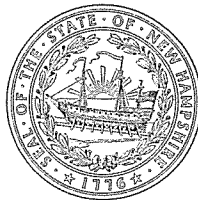
