AGREEMENT made this 30<sup>th</sup> day of November, 2009, by and between Union Telephone Company, a New Hampshire corporation with an address of 7 Central Street, Farmington, New Hampshire (hereinafter referred to as "Union") and New Hampshire corporations Unex, Inc., UTEL, Inc., CenCel, Inc., ACN, Inc., and Freedom Ring Communications LLC d/b/a BayRing Communications (a Maine limited liability company). All of the above companies, except Union, hereinafter are referred to as "Affiliates".


WHEREAS, all of the issued and outstanding shares of stock in Union Telephone Company were purchased effective November 30, 2009 by TDS Telecommunications Corporation pursuant to a certain Stock and Asset Purchase Agreement by and among the TDS Telecommunications Corporation, Union, Unex, Inc., Freedom Ring Communications LLC and Utel, Inc. dated as of July 27, 2009


WHEREAS, Union is no longer considered an affiliate of the Affiliates (Utel, Inc. or its subsidiaries) covered under the previous agreement between Union Telephone Company and its affiliates.


NOW THEREFORE, in consideration of the mutual covenants and agreements herein set forth, Union and the Affiliates, effective as of 11:59 p.m. on November 30, 2009, hereby terminate the agreement between Union Telephone Company and its affiliates dated December 23, 2004.
