6. (a) Summary of the subject matter, or summary of the rule if drafted, and the effect on those regulated:

RSA 365:8-a authorizes the New Hampshire Public Utilities Commission (PUC) to adopt rules establishing requirements for suppliers of natural gas and aggregators of natural gas customers, including registration of such suppliers and aggregators before soliciting or doing business in the state, registration fees, disclosure of information to customers, standards of conduct, submission to commission jurisdiction for mediation and resolution of disputes, imposition of penalties for failure to comply with commission requirements, and consumer protection and assistance requirements. The current rules governing this conduct are to expire in 2010. The PUC intends, therefore, to readopt the rules, and to include revisions and updates to the registration and reporting requirements for suppliers of natural gas and aggregators of natural gas customers.

6. (b) Brief description of the groups affected:

The rules and amendments affect suppliers of natural gas, aggregators of natural gas customers and may also affect natural gas local delivery companies and the customers of these entities.
