

This is a friendly reminder that your registration with the New Hampshire Public Utilities Commission (Commission) to provide electric aggregation service in New Hampshire, will expire on April 5, 2010. 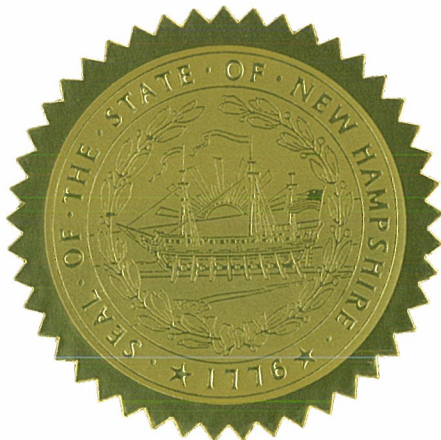
