Dear Mr. McNeil:

On March 29, 2010, you submitted applications on behalf of homeowners George W. and Linda S. West, Frank D. Shaw, Patrick B. Miller, Stephen Farish and Jeanette Heidmann, and Carol L. Jowdy requesting certification of customer-sited rooftop photovoltaic facilities as eligible to produce Class II renewable energy certificates (RECs) pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law. Staff has reviewed the applications and recommended approval noting that the applications were complete on March 29, 2010.

Class II eligibility requires that a facility began operation after January 1, 2006 and that it produces electricity from solar technologies. The applications indicate that the facilities are customer-sited photovoltaic rooftop arrays located in New Hampshire and that they began operation in 2009 and 2010. The details for each facility are listed in the table on the following page.

Since the facilities are customer-sited sources, their output is not recorded in the NEPOOL Market Settlement System and, as a result, their output must be monitored and verified by an independent monitor. The applications state that NHEC will monitor the facilities' output as required by N.H. Code of Administrative Rules Puc 2505.08. These facilities' total output will also be included in the NHEC Class II Aggregation's total

Jowdy facilities are Class II renewable energy sources effective March 29, 2010 and are eligible to be issued New Hampshire Class II renewable energy certificates.

The New Hampshire Renewable Portfolio Standard certification codes for the NHEC solar photovoltaic facilities are listed in the previous table.
