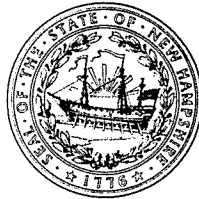

Re: DE 10-101, New Hampshire Electric Cooperative, Inc. Certification Application for Class I Eligibility Pursuant to RSA 362-F on behalf of homeowner David E. Horton

Dear Mr. McNeil:

On April 12, 2010, you submitted an application on behalf of homeowner David E. Horton requesting certification of his customer-sited wind power facility as eligible to produce Class I renewable energy certificates (RECs) pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law. Staff has reviewed the application and recommended approval noting that the application was complete on April 12, 2010.

Class I eligibility requires a facility to have begun the production of electricity after January 1, 2006 and to use certain sources to produce electricity, one of which is wind energy. The application indicates that the facility is a customer-sited wind power facility located in Holderness, New Hampshire and began operation on February 16, 2010.¹ The facility has a gross nameplate capacity of 10 kilowatts.

Since the facility is a customer-sited source, its output is not recorded in the NEPOOL Market Settlement System and, as a result, its output must be monitored and verified by an independent monitor. The application states that NHEC will monitor the facility's output as required by New Hampshire Code of Administrative Rules Puc


¹ NHEC considers the operation date disclosed above, and in Appendix E of the application, to be the date on which NHEC inspected the facility and installed a revenue quality meter to record the electricity that will be eligible for Class I RECs. The date listed in each interconnection application pertains to the installation and interconnection of the facility and may be different than the operation date stated above.

2505.08. The facility's total output will also be included in the *NHEC Class I Aggregation's* total output reported to the NEPOOL Generation Information System as approved by the Commission on April 9, 2010.

Based on Staff's recommendation, the Commission has determined that NHEC has provided all the necessary information to demonstrate that the facility is eligible for certification as a Class I facility. Therefore, the Commission hereby certifies that the David E. Horton facility is a Class I renewable energy source effective April 12, 2010 and is eligible to be issued New Hampshire Class I renewable energy certificates.

The New Hampshire Renewable Portfolio Standard certification code for the David E. Horton wind power facility is NH-I-10-049.
