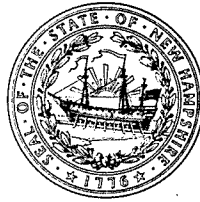

Registration Renewal as a Natural Gas Aggregator

Dear Mr. Mathers:

On April 28, 2010, Consumer Energy Solutions, Inc. filed with the New Hampshire Public Utilities Commission (Commission) application for registration renewal as natural gas aggregator. After discussions with Staff related to the initial renewal application, on May 17, 2010, Consumer Energy Solutions, Inc. filed a correction to its earlier renewal application.

The Commission has reviewed Consumer Energy Solutions, Inc.'s completed application for its renewal registration as a natural gas aggregator. The application meets the requirements for registration pursuant to N.H. Code Admin. Rules Puc 3003.02. Therefore, the Commission will approve Consumer Energy Solutions, Inc. renewal as a natural gas aggregator in the State of New Hampshire, with the registration to be effective June 28, 2010, coinciding with the expiration of the current registration. This registration will expire at the end of business on June 27, 2012.


Additionally, please bear in mind that, pursuant to N.H. Code Admin. Rules Puc 3003.02 (e), each aggregator applicant shall re-register with the Commission every 2 years by filing an application for renewal at least 60 days prior to the expiration of its registration, i.e., in the case of Consumer Energy Solutions, Inc., on or before April 27, 2012. Pursuant to Puc 3003.02 (d), each natural gas aggregator shall notify any LDC in whose service territory it intends to do business of the filing of its registration or renewal application at the time it files such an application with the Commission. There is currently no provision in N.H. Code Admin. Rules Puc 3003.02 which requires a fee for the renewal of the registration as a natural gas aggregator.

All registered Natural Gas Aggregators in the State of New Hampshire are subject to specific requirements spelled out in N.H. Code Admin. Rules Puc 3000 – Competitive Natural Gas Marketer Rules.
