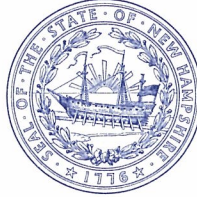

To the Parties:

On October 12, 2010, TransCanada Power Marketing Ltd. and TransCanada Hydro Northeast, Inc. (collectively, "TransCanada") filed a motion to suspend the above-referenced proceeding. The pending motion requests that the Commission suspend the proceeding until a decision is reached on the motion for protective order filed by Public Service Company of New Hampshire on August 26, 2010. TransCanada represents in its motion that the Conservation Law Foundation, the Sierra Club and the Office of the Consumer Advocate support the motion, that PSNH does not object to the motion, and that Staff takes no position on the motion.

The Commission has determined that the granting of this motion is consistent with the public interest. Accordingly, the proceeding is suspended until further notice.
