

Re: DE 10-177 and DE 10-179, Conservation Services Group's Certification Applications for Class II Eligibility Pursuant to RSA 362-F on behalf of the Plainville Board of Education

Dear Ms. Stanton:

On June 28, 2010, you submitted applications on behalf of the Plainville Board of Education requesting certification of the Toffolon Elementary School and the Plainville High School customer-sited photovoltaic rooftop arrays (Toffolon and Plainville facilities) as eligible to produce Class II renewable energy certificates (RECs) pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law. Staff has reviewed your applications and recommended approval noting that the Conservation Services Group applications were completed on June 28, 2010.

Class II eligibility requires a facility to have begun the production of electricity after January 1, 2006 and that it produces electricity from solar technologies. The applications indicate that the Toffolon and Plainville facilities are customer-sited photovoltaic rooftop arrays located in Plainville, Connecticut. The details for each facility are listed in the following table.



Since the facilities are customer-sited sources, their output is not recorded in the New England Power Pool (NEPOOL) Market Settlement System and, as a result, their output must be monitored and verified by an independent monitor. The applications state that Peregrine Energy Group, Inc. will monitor the facilities' output as required by the New Hampshire Code of Administrative Rules Puc 2505.09.<sup>1</sup>

Based on Staff's recommendation, the Commission has determined that you have provided all the necessary information to demonstrate that the Toffolon and Plainville facilities are eligible for certification as Class II facilities. Therefore, the Commission hereby certifies that the Toffolon and Plainville facilities are Class II renewable energy sources effective June 28, 2010 and are eligible to be issued New Hampshire Class II renewable energy certificates.

Attached please find a copy of the notice of this certification provided to the GIS administrator. The New Hampshire Renewable Portfolio Standard certification codes for the Toffolon and Plainville facilities are provided in the table on the previous page.



Please be advised that, pursuant to RSA 362-F, the New Hampshire Public Utilities Commission has certified the Toffolon Elementary School and the Plainville High School customer-sited photovoltaic rooftop arrays (Toffolon and Plainville facilities) owned by the Plainville Board of Education as Class II renewable energy sources effective June 28, 2010. Accordingly, the Toffolon and Plainville facilities are eligible to be issued New Hampshire Class II Renewable Energy Certificates. Each facility's size and location are listed in the following table.
