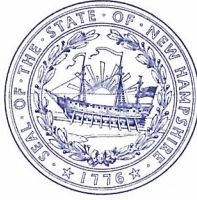

To the Parties:

On December 13, 2011, Public Service Company of New Hampshire (PSNH) filed a request to extend the December 13, 2011 deadline for filing a settlement agreement to December 15, 2011 in the above-referenced matter. The Office of the Consumer Advocate also filed on December 13th a request to extend the deadline for rebuttal testimony from December 16, 2011 to December 19, 2011.

The Commission has determined that the granting the extensions will not unduly delay the proceeding or adversely affect the rights of any party. Accordingly, the deadline for filing the settlement agreement is extended to December 15, 2011 and rebuttal testimony is due December 19, 2011.
