Re: DE 10-188, CORE Electric Energy Efficiency and Gas Energy Efficiency Programs  
Unitil and Northern Tariff Revisions for CDFA Grant

To the Parties:

On August 21, 2012, Unitil Energy Systems, Inc. (Unitil) and Northern Utilities, Inc. (Northern) filed amended tariff pages for the Residential Energy Efficiency Loan Programs. The tariff contained an effective date of September 1, 2012 and the 30-day notice requirement for filed tariffs expired September 20, 2012. In support of the tariffs, Unitil and Northern attached copies of the executed agreement between Unitil, Northern, and New Hampshire Community Development Finance Authority (CDFA).

The loan program contains implementation provisions that are similar to the provisions Public Service Company of New Hampshire explained in its letter dated May 18, 2012: no shareholder incentive is earned on the loan program; CDFA funds will be tracked separately from any System Benefit Charge or Regional Greenhouse Gas Initiative funds; the collaboration agreement with CDFA runs through April 2013; and the funds are supplementing programs already approved by the Commission.

Because of certain typographical errors in the filed tariffs, Unitil and Northern submitted corrected versions of the tariffs on September 24 and 28, 2012. Accordingly, the Commission has determined that the tariffs be allowed to go into effect by operation of law.
