On December 27, 2011, Staff filed a status report concerning the above-captioned proceeding. In its report, Staff noted that it had reached agreement with Comcast that Comcast would file a petition for a general license covering all existing Comcast crossings in New Hampshire that meet specified requirements and are classified at and above the 4<sup>th</sup> Order River level, as set forth in the N.H. Department of Environmental Services Official List of Public Waters. Staff's filing included a request on behalf of Comcast for an extension of time for filing the petition to no later than February 29, 2012.

The Commission has determined that the extension is reasonable and will not unduly delay the proceeding or adversely affect the rights of any party. Accordingly, the deadline for filing the petition is extended to February 29, 2012.
