1. Petitioner, John Martino, resides in Salem, NH.
2. Petitioner is a low income electric customer of Granite State Electric Company, d/b/a, National Grid NH (the Company).
3. Petitioner receives an electric bill discount under the Company's Electric Assistance Program (EAP).
4. Petitioner is on the waiting list for low-income weatherization services.
5. Petitioner has an interest in this proceeding as a residential customer of the Company.
6. Petitioner seeks to assure in this proceeding that Liberty Energy Utilities Corporation agrees to maintain and participate in the Electric Assistance Program (EAP) if the Commission approves the proposed transfer of ownership requested in the Joint Petition For Transfer Of Ownership filed in this docket.
7. Petitioner seeks to assure in this proceeding that Liberty Energy Utilities Corporation agrees to maintain and participate in the Home Energy Assistance (HEA) low-

income electric customer weatherization program if the Commission approves the proposed transfer of ownership requested in the Joint Petition For Transfer Of Ownership filed in this docket.

8. The rights, duties, privileges, and other substantial interests of Petitioner may be affected by this proceeding.


9. Petitioner seeks to intervene as a full party intervenor herein.
