10.2 ISDN Primary Service

10.2.10 ISDN PRI Service – Local Usage Bundles (A-C)	
A.	The ISDN PRI Local Usage Bundle options listed below include ISDN primary port, local distribution channel (LDC), Calling Line Identification with Name and 1 DID block. These bundles are provided under a 1, 2 or 3 year terms. The bundle rates do not include the EUCL, surcharges or taxes. <ul style="list-style-type: none"> • ISDN PRI Bundle (A) – unlimited local calling • ISDN PRI Bundle (B) – 25,000 local usage minutes of use • ISDN PRI Bundle (C) - no local usage included; also includes month-to-month option
B.	All regulations applicable to ISDN Primary Service as specified in Part C, Section 10 of this Tariff apply to the ISDN PRI Local Usage Bundles (A-C) except as specified in Section 10.2.10.
C.	ISDN PRI Local Usage Bundles (A-C) are not available with Foreign Exchange service, virtual private network services and are not available with services provided under special contract.
D.	ISDN PRI Local Usage Bundles (A-C) are not available with the following business packages or optional plans: FairPoint Business Extra, Corporate Rewards, or in combination with other regional optional calling plans.
E.	ISDN PRI Local Usage Bundles (A-C) is not available with VTPP found in Section 10.
F.	Service and Equipment Charges (S&E) do not apply when installing new ISDN PRI Local Usage Bundles (A-C) service under a 1, 2 or 3 year term. This charge will not be waived under a month-to-month (MTM) term. Only Bundle C has a MTM term.
G.	The ISDN PRI Local Usage Bundles (A-C) are not subject to temporary suspension of service.
H.	Conversion- Any existing ISDN PRI customer may convert to ISDN PRI Local Usage Bundles (A-C). However, this will be considered a downgrade and termination charges will apply to the existing service agreement.
I.	Termination Charges ISDN PRI Local Usage Bundle (A-C). If the customer disconnects prior to fulfillment of term, a charge will be assessed for the number of months (rounded up) in service multiplied by \$20, \$40 or \$60 depending on the term. The customer will also be assessed the NRC. Further information is found in exhibit 10.2.10-1 of this section.
