To the Parties:

By letter dated March 12, 2015, F. Anne Ross, Esq. and Thomas C. Frantz requested that they be designated as Staff Advocates in the above-referenced dockets pursuant to RSA 363:32, II. Their request was based upon their participation in settlement discussions and upon their commitment to support a proposed settlement of those dockets. Upon review of the facts stated in the March 12, 2015 letter, the Commissioners designated Attorney Ross and Mr. Frantz as Staff Advocates in Dockets DE 11-250 and DE 14-238.

RSA 363:35 provides that no Commission employee designated as a Staff Advocate "may advise the commission, its presiding officer, individual commissioners, or any decisional employee designated as such in the same proceeding, with respect to matters at issue in the contested case." These limitations will apply to Attorney Ross and Mr. Frantz for the remainder of these proceedings but shall not affect their involvement in any other matters before the Commission.
