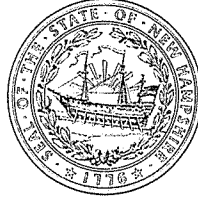

Tariff Introducing DID Numbers to ISDN PRI Local Usage Bundle Customers

Dear Ms. Wennerstrand:

On January 25, 2012, FairPoint Communications - NNE (FairPoint) filed a tariff introducing DID numbers, in blocks of 100 and individually, to customers purchasing ISDN PRI Local Usage Bundle A, B, or C.

Staff reviewed the cost data included with the filing and recommended that the tariff be allowed to go into effect by operation of law. The Commission has accepted Staff's recommendation to allow the tariff to go into effect.

For administrative efficiency, an order will not be issued by the Commission to suspend, reject, or approve the proposed tariff changes. Pursuant to RSA 378:3 and RSA 378:6, IV, and pursuant to Staff's recommendation, the proposed tariff, as filed, is effective as of February 24, 2012. Tariff pages should be filed referencing Docket No. DT 12-028 and should reflect the effective date of February 24, 2012.
