Request for Certification as an Independent Monitor Pursuant to Puc 2505.09

Dear Mr. Randall:

On February 8, 2012, the New Hampshire Public Utilities Commission (Commission) received an application from Draker Laboratories (Draker) seeking certification as an independent monitor pursuant to N. H. Code of Administrative Rules Puc 2505.09. Draker had proposed that the firm would provide monitoring services for owners of customer-sited sources in New Hampshire that qualify for New Hampshire renewable energy certificates (RECs).

Puc 2505.09 sets out requirements that must be met by an applicant in order to be certified as an independent monitor. In order to be eligible for certification an organization must show that its inspectors have been licensed by various licensing authorities. According to Staff's recommendation dated October 12, 2012, this matter was discussed on several occasions with Aimee S. Green, Project Manager, but you have not filed documentation of the required licenses for the inspectors you propose to use on projects in New Hampshire.

Accordingly, the Commission has denied (without prejudice) Draker's request for certification as an independent monitor and closed DE 12-038.
