On February 16, 2012, the PUC received an application requesting that Record Hill Wind's electrical production be granted eligibility as a Class I facility pursuant to RSA 362-F, New Hampshire's Renewable Portfolio Standard law. On March 02, 2012, Staff requested additional information. Information required to complete the application was received on May 22, 2012. Staff has reviewed the application and recommends approval, noting that all information required to complete the application in accordance with New Hampshire Code of Administrative Rules Puc 2500, was received on May 22, 2012.

The Record Hill Wind farm is located in Roxbury, Maine and consists of 22 Siemens SWT-2.3-93 turbines rated at 2.3 MW each for a total generation of 50.6 MW. Record Hill Wind commenced operations on November 28, 2011. Record Hill Wind's application provided evidence of approvals from multiple regulatory agencies including federal, state, and local entities. Record Hill Wind's renewable electricity generation is transmitted to the Central Maine Power Company's Roxbury Substation and on to the grid.

The NEPOOL generation information system (GIS) facility code has been verified as MSS 14665. The ISO-New England asset identification number is 14665.

The Commission has reviewed the Record Hill Wind application for RECs and determined that all necessary documentation has been provided to demonstrate this facility meets all the requirements of Puc 2502.02 and is eligible for certification as a New Hampshire Class I facility.
