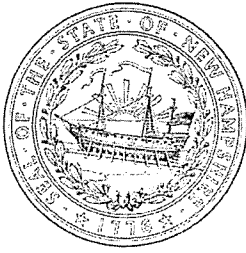

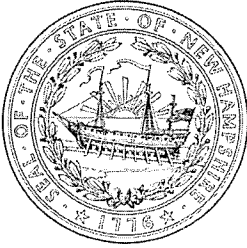

### **BY-LAWS**

#### Offices

- Section 1. Principle Office shall be located in the City of Nashua, NH 03064 at 23 Danbury Rd
- Section 2. Registered Office of the corporation shall be located in the City of Nashua, NH 03064 at 23 Danbury Rd

#### Board Of Directors

- Section 1. The Comapny and its affairs shall be controlled by its Board of Directors.
- Section 2. The Company shall have two members of the Board Of Directors:
1. Matthew Trombly – President & CEO
  2. Philip Trombly - Vice President/Director of Sales
- Section 3. No other Directors shall be elected or appointed without full agreement by and between existing Board of Directors.

#### Scope of Work

- Section 1. American New Energy is an energy consultant focused on helping its clients identify energy cost savings solutions on both the demand and supply side of their bill. Our primary focus will be on brokering electricity supply in deregulated markets and completing general energy efficiency retrofits with applications such as lighting, controls and energy management.

#### Stock

- Section 1. Company has issued 10,000,000 shares of common stock to shareholders as described below:

Section 2. Company stock may be sold at the sole discretion of Matthew Trombly.

### Meetings
