Re: DT 12-107, New Hampshire Optical Systems, Inc. Petition for an Investigation into Proposed Charges for Utility Pole Make Ready Regarding Notice of Settlement and Closing Docket

To the Parties:

By letter dated June 24, 2013, counsel for New Hampshire Optical Systems, Inc. (NHOS) informed the Commission that NHOS and segTEL, Inc. had reached a settlement of the disputes between such parties that NHOS raised or could have raised in Docket DT 12-107, and that, from NHOS's perspective, the settlement resolves all make-ready issues impeding the completion of the Middle Mile Project which are within the scope of this docket.

NHOS' counsel had previously informed the Commission, by letter dated June 3, 2013, that resolution of the segTEL dispute would resolve all make-ready issues within the scope of the Commission's investigation in this docket and that no further investigation by the Commission would be required following such settlement.

Based on this correspondence from NHOS, the Commission deems NHOS' petition for investigation to have been withdrawn and accordingly will close this docket.
