According to the May 31, 2012 Hearings Examiner's report, Northern Utilities, Inc. (Northern) agreed to file a report with background and other information regarding the cost allocation issue which is the subject of the instant docket. On June 11, 2012, Northern filed a request to extend the time to file the report from June 22, 2012 until July 20, 2012 noting that Northern needs additional time to complete the report. Northern states in its request that Staff and the Office of Consumer Advocate do not oppose the request for an extension.
