Dear Ms. Howland:

North American Power and Gas, LLC (“NAPG”) hereby notifies the Commission that it has completed electronic data interface (“EDI”) training and testing process in the Liberty (Granite State Electric) and Unitil service territories. Copies of the approval documentation effective as of July 3, 2013 and August 23, 2013, respectively, are attached hereto as Exhibit A and Exhibit B.

Accordingly, with these requirements satisfied, NAPG requests expansion of its current November 13, 2012 Competitive Electric Power Supplier (“CEPS”) registration for the PSNH territory to include Liberty and Unitil territories as well. This consolidated request comports with the Staff’s recommendation and the Commission’s review as reflected in the November 13 registration, at p. 2 (emphasis added):

Staff recommended that NAPower can request extension of its service to the service territories of [utilities in addition to PSNH] by updating its application with documentation demonstrating successful completion of the testing. Upon receipt of such submittal, Staff will review the information and make a recommendation to the Commission. It was


recommended that NAPower consolidate the submittal of such updates to result in a more efficient review process.
