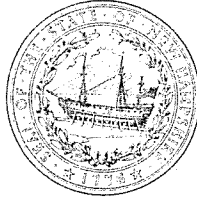

Dear Mr. Nicholson:

On May 24, 2012, Bretton Woods Telephone Company submitted a filing to revise its NHPUC tariff to establish a process for identifying and rating VoIP / PSTN traffic. The proposed revision addresses new requirements established by the Federal Communications Commission (FCC) regarding VoIP traffic charges.

Staff reviewed this revision and concluded that it is consistent with FCC requirements and provides a reasonable process for identifying and rating the traffic involved. The Commission has accepted Staff's assessment. Pursuant to RSA 378:3 and RSA 378:6, IV, the revision has gone into effect by operation of law on July 1, 2012. Tariff pages should be filed referencing Docket No. DT 12-144 and reflecting the effective date of July 1, 2012.
