This is to confirm that the New Hampshire Public Utilities Commission (Commission) has received NextEra Energy Services New Hampshire, LLC (NextEra)'s request to add New Hampshire Electric Co-Op (NHEC) service territory to the areas of the state in which it may provide competitive electric power supplier service and notice that it intends to serve all customer classes in a utilities' applicable tariff.
