Re: DT 07-011; Northern New England Telephone Operations LLC d/b/a FairPoint Communications – NNE (“FairPoint”) Revised Broadband Expansion Proposal

Dear Ms. Howland:

This submission is made pursuant to Order No.: 25,379 dated June 26, 2012 (the “June Order”) in which the New Hampshire Public Utilities Commission (the “Commission”) granted FairPoint permission to pursue the Broadband Expansion Agreement, identified as Attachment A in FairPoint’s submission of June 6, 2012. As the Commission knows, that executed agreement between the New Hampshire Attorney General’s Office (on behalf of the Commission), FairPoint and the Department of Resources and Economic Development (“DRED”) was submitted on June 28, 2012, and Governor John Lynch and Executive Council approved the agreement on July 11, 2012. On November 1, 2012, FairPoint submitted its broadband proposal to the Commission.

More recently, FairPoint and the Commission Staff (“Staff”) have continued efforts to review the proposal and work through any questions or issues related to Staff’s review. As a result of these discussions, the original proposal has been slightly modified. DRED has also been made aware of the modifications and is in support of the proposal. With this submission, FairPoint hereby files its revised broadband expansion proposal.

FairPoint is pleased to report that the revised Broadband proposal is also a far-reaching plan touching all ten (10) New Hampshire counties and expanding broadband to two thousand five hundred and seventeen (2,517) access lines. FairPoint believes that use of the \$3,323,751 broadband expansion funds will best serve the state of New Hampshire and provide broadband opportunities to a market that may not otherwise ever receive access to Broadband.

Due to the sensitive nature of the supporting information in the revised proposal, FairPoint requests confidential treatment of the plan. FairPoint represents that the materials marked “Confidential and Proprietary Information” pertain to the provision of competitive services; set forth trade secrets or other




