Dear Ms. Parker:

On July 6, 2010 the Commission received a letter from Comcast Phone of New Hampshire (Comcast Phone) which, among other things, objected to being made a mandatory party to the above-referenced docket. In the course of that letter, Comcast Phone also proposed that in lieu of being made a party, it would "work with Commission Staff to provide targeted information, in a format that is acceptable to the parties and on a confidential basis (if necessary) — either through stipulated facts, affidavit, or limited discovery — in order to assist the Commission in making the competitiveness determination required pursuant to RSA 374:3-b." The Commission, through Order No. 25,130 (July 15, 2010), granted Comcast Phone's request not to be made a mandatory party, in part, on the willingness of Comcast Phone to provide information.

In light of the above, the Commission Staff is submitting the attached questions to Comcast Phone in order to obtain information that may be useful in resolving the issues presented in the docket. Staff requests that the responses be in the form of an affidavit or other sworn statement, consistent with the representation made in above-referenced letter.
